Security features include role-based permissions, automatic access time-out, and multi-factor authentication (MFA).

Target Users: The software is designed for all authorized personnel within behavioral health and addiction treatment centers, including clinical providers, medical staff, intake/admissions, administrative staff, and billing/claims staff. It is scalable to support organizations from 2 users to thousands.
