The platform's core is its proprietary Clinical Intelligence System, an algorithm-based engine that synthesizes **EHR data**, **electronic Patient-Reported Outcomes (ePROs)**, and **evidence-based clinical guidelines** into a single, cohesive solution.

The software is delivered as a cloud-based (SaaS) solution, designed to be embedded directly within the Electronic Health Record (EHR) workflow, notably with Cerner, which eliminates the need for dual documentation and drives time savings for clinicians.

### Key Capabilities & Benefits:

**Personalized Care Plans:** The system auto-generates individualized, evidence-based cancer and survivorship care plans in minutes, a process that traditionally takes significantly longer.
