The platform utilizes voice-based AI (ambient scribe) and Natural Language Processing (NLP) technology, trained on one of the industry's largest datasets of real-world treatment sessions, to securely capture and analyze therapy sessions.

**Eleos Documentation:** The core feature that works by turning ambient session audio or short bullet points into detailed, compliant, and clinically rich progress notes, reducing documentation time by over 70%. Providers typically accept approximately 80% of the system's documentation suggestions.

**Eleos Compliance:** An AI-enabled solution that automatically scans 100% of eligible progress notes across various domains to flag potential documentation errors before a claim is submitted, simplifying the appeals process and supporting accreditation.

**Clinical Insights:** Provides real-time, actionable insights and analytics into treatment effectiveness, helping to drive evidence-based care and improve client outcomes.
