The solution is designed to support patients throughout the care continuum, from screening to survivorship. ECS aims to improve clinical outcomes, streamline operations, and optimize revenue generation for cancer centers and medical facilities.

Key Capabilities:

Patient Navigation: Tools for patient triage, managing barriers to care, and navigation for supportive services.

Survivorship Care Planning: Enables the creation of customized, follow-up plans, including treatment summaries, education, and future appointment recommendations, which is critical for meeting accreditation standards.

ECS is a multi-facility tool that is highly interoperable, offering deep, direct integration with major Oncology Information Systems (OIS) and Electronic Health Records (EHRs) via HL7 and other interfaces.
