EVV Compliance: The system is designed to meet or exceed state and federal mandates, including the 21st Century Cures Act, by electronically verifying visits using multiple methods: Mobile App (GPS verification at clock-in/out), Telephony (IVR), and FOB devices.

Integrated Management: It manages the entire workflow, including referrals, patient intake, scheduling, billing, and payroll integration, replacing manual data entry and paper timesheets.

Scheduling: Offers smart scheduling tools that match caregiver availability with patient needs, validate against authorizations, and flag compliance expirations.

Financial Accuracy: Features pre-billing validations and safety nets to identify potential compliance issues before billing, which increases first-pass clean claim acceptance rates and speeds up reimbursement cycles.

Caregiver Empowerment: The HHAEExchange+ Mobile App allows caregivers to clock in/out, view real-time schedules, get directions, log plan of care tasks, capture electronic signatures, and communicate securely with the agency via a HIPAA-compliant two-way chat.

Data & Reporting: Provides real-time visibility into visits via a Call Dashboard and offers comprehensive EVV compliance reports and insights into compliance trends, cash flow, and patient outcomes.
