Developed by a clinical psychiatrist, the system is known for its unique, button-driven interface that automatically generates detailed, narrative, and insurance-compliant clinical documentation (such as initial assessments, treatment plans, and progress notes) with minimal typing. This feature is designed to significantly reduce the time spent on paperwork, allowing clinicians to focus more on patient care.

The platform is a fully integrated practice management solution, combining charting with essential administrative and financial tools. Key capabilities include:

Clinical Documentation: Menu-driven templates for individual, couples, and group therapy notes, treatment plans, and assessments. It includes over 100 electronic rating scales and assessment tools, and a newer ICANotes+ version features an AI ambient listening scribe.

Practice Management: Robust features for scheduling (multi-provider/multi-location views), comprehensive billing (insurance verification, claims submission, ERA auto-posting, claim scrubbing, E/M coding automation), and patient payments.

Patient Engagement: A secure, HIPAA-compliant client portal for digital intake forms, secure messaging, appointment confirmations, and document sharing.

Medication Management: Integrated e-prescribing for standard and controlled substances, including integrated PDMP (Prescription Drug Monitoring Program) access.

Telehealth: Built-in HIPAA-compliant virtual care functionality.

The system is cloud-based, OS agnostic, and suitable for all practice sizes, from solo practitioners to large organizations. It is ONC-certified and HIPAA-compliant, making it an audit-ready solution for mental health practices.
