Relativity is a comprehensive and extensible legal technology platform designed to manage and analyze large volumes of electronic data for e-discovery, internal investigations, and compliance reviews. The platform offers two primary deployment options: **RelativityOne**, the secure, cloud-based SaaS solution built on Microsoft Azure, and **Relativity Server**, the on-premise offering.

Relativity simplifies and accelerates the entire e-discovery lifecycle, from legal hold and data collection to processing, review, and production. Key capabilities include advanced analytics, machine learning, and visualization tools to quickly identify key issues and prioritize data sets. The platform is highly customizable, allowing users to create tailored workflows and utilize the **Relativity App Hub**—an API-powered marketplace—to integrate custom solutions and third-party applications.

Key Features and Capabilities:

Relativity aiR: Al-powered solutions for generative Al-assisted document review, privilege review, and data breach response.

Legal Hold: Centralized, defensible, and repeatable process for preserving electronically stored information (ESI).
