The software aggregates and analyzes data from the EHR and other disparate hospital information systems in real-time to identify at-risk patients and staff, alerting clinical teams to opportunities to deliver evidence-based care and improve quality and safety.

Sentri7 offers a suite of specialized modules to address critical clinical and operational challenges:

Infection Prevention: Proactively identifies healthcare-acquired infections (HAIs) and trends sooner, streamlines regulatory reporting (including one-click submissions to NHSN), and helps manage multi-drug resistant organisms.
